HIGHLIGHTING INTRODUCTORY PHARMACY PRACTICE EXPERIENCES—IPPES

The purpose of the Introductory Pharmacy Practice Eexperiences curriculum is to provide students exposure to difference types of pharmacy practice settings and to gaining introductory experiences, knowledge and skills, all prior to their fourth year of pharmacy school. At University of Houston College of Pharmacy (UHCOP), IPPEs currently take place during the second and third year of the pharmacy curriculum for a total of 300 hours. The program consists of three components:

IPPE I: Fall Semester, P2 Year

Introductory MTM Training: Students participate in an introductory Medication Therapy Management (MTM) training, service learning, and shadowing activities. MTM training takes place in a nursing home setting where students review medical charts, develop therapeutic plans, and simulate a comprehensive medication review (CMR) and patient counseling. The MTM training is guided by UHCOP faculty where students' didactic knowledge of pharmacology is incorporated into the training.

Service Learning: In preparation for service learning, students are trained to perform blood pressure, glucose, osteoporosis and cholesterol screenings as well as diabetic foot examinations. During Fall 2012, in collaboration with various pharmacy organizations, students performed over 2,400 hours of community and were an integral part of the success of APHA-ASP's first Community Health Awareness Day Health Fair held at the UH main campus. In addition to screenings and medication reviews, students also collected unwanted medications as part of a medication take-back program. Other service learning activities during the semester included assisting NCPA with the Diabetes Awareness Day held at a local YMCA and sponsored by Texas State Representative Carol Alvarado, assisting with employee health screenings at various hospitals of The Methodist Hospital Health System, and other various events.



Shadowing: In this final component, students shadow pharmacists in the practice areas of hospital pharmacy, independent community pharmacy, as well as at the HOMES and/or HOPE clinics, gaining valuable firsthand information and experiences from several different types of pharmacy settings.

HIGHLIGHTING INTRODUCTORY PHARMACY PRACTICE EXPERIENCES—IPPES

Introductory Community Pharmacy: Summer Semester after P2 Year

Students are assigned to a 4-week, 170– hour Introductory Community Pharmacy IPPE. Prior to this IPPE, the students complete a course entitled Pharmacy Practice IV. This course focuses on community pharmacy where the students learn about laws governing community pharmacy as well as dispensing practices and patient counseling. This IPPE allows students to apply their pharmacy knowledge and skills in a community pharmacy setting where they are expected to counsel patients and be integrated into the workflow



of the community pharmacy. In addition, students provide immunizations and document any type of interventions they make while at the site. This IPPE is an excellent way for the students to learn to interact with patients and other healthcare professionals. For many, this is the first opportunity to gain valuable experience working in a pharmacy.

IPPE 2: Spring Semester of P3 Year

The focus of this IPPE is health-system pharmacy where students are assigned to either 2-week or 4-week, 64 hour IPPEs in an institutional setting. Students are certified in aseptic preparation of sterile parenteral products prior to this IPPE and are expected to learn the many aspects of health-systems pharmacy from distribution, management, and patient care during the experience. Some of the activities students participate in include but are not limited to medication reconciliation, discharge counseling, rounding with pharmacists and medical teams, and working in the IV room. Students also review patient charts and prepare a journal club and a patient case presentation.



Future Plans for IPPEs at UHCOP:

The college's Curriculum Committee along with the Office of Experiential Programs are discussing expanding the IPPEs to be incorporated into the first year of the professional pharmacy program. In addition, simulation activities including simulated electronic medical records and participation in interprofessional education with medical and nursing students are also being considered.



The student schedule will have the Time Frame, Course/Rotation, Site, and Student(s) Name.




APPE Students in the SPOTLIGHT


