If applicant holds a license as a Master Social Worker, applicant will be required to always be in supervision while employee at Severance Psychotherapy. External supervision is permitted if outside supervision is preferred. However, our on-staff supervisor(s) are able to supervise Severance employees who are interested in working toward there clinical license. Willing to be flexible as Severance grows and finds new ways to improve processes. All candidates must be willing to perform a drug screening and background check if chosen to move forward through the onboarding process.
